Information on the School Assistance Program for FY 2026

就学援助制度とは？ What is the School Assistance Program?

保護者の経済的理由によりお子さんの就学が困難な場合、市が保護者に対し、経済的負担を軽減するため、就学に必要な費用の一部を援助する制度です。The School Assistance Program is a system in which the city provides financial support to reduce the economic burden on guardians when it becomes difficult for their children to attend school due to financial reasons.

This program offers assistance for part of the expenses necessary for schooling.

※学校徴収金(校納金)が免除される制度ではありません。Please note that this is not a system that exempts school fees (school collection fees).

1. 援助対象になる方(以下の条件全てに該当している方)

Eligibility for Assistance (Applicants must meet all of the following conditions)

- 湖西市内の小中学校に通うお子さんがいる保護者
 - The guardian must have a child attending an elementary or junior high school in Kosai City.
- 世帯全員(生計同一者)の所得額が、生活保護基準の1.3倍未満の方
 - The total income of all household members (those who share the same livelihood) must be less than 1.3 times the minimum living standard under the Public Assistance Act.

例)令和8年度に申請する方は令和7年(R7.1.1~R7.12.31)の所得で審査します。

Example: For those applying for assistance for Fiscal Year 2026 (Reiwa 8), the household income for Reiwa 7 (Jan. 1 - Dec. 31) will be reviewed.

※同一住所で世帯分離していても同一世帯とみなします。

※ Even if household members are registered separately but live at the same address, they are considered part of the same household.

・生活保護基準は世帯構成等により変動するため世帯ごとに異なります。

The minimum living standard varies depending on household composition.

・生活保護基準は厚生労働省による改定により変動します。

The standard may change with revisions made by the Ministry of Health, Labour and Welfare.

上記の認定基準に該当しているかは、申請をいただいた後の審査により決定します。

Whether an applicant meets the above eligibility criteria will be determined after the application is submitted and reviewed.

※要保護(生活保護の受給有)の方の申請は不要です。※ Those who are already receiving public assistance (welfare) do not need to apply.

※ For items marked with “(annual amount),” the listed amount is provided only to those who apply before the start of the school year and are approved.

For all items, eligibility for support begins from the month following the month of application.

Therefore, applicants who apply and are approved mid-year will receive a reduced amount compared to the amounts shown above.

3. 申請の流れ Application Process



1.Reception (At the city or school) 2. Application (To the city or school) 3. Eligibility Review (City board of education) 4. Notification of Results (Will be mailed to your home) 5. Payment

※①経済的に困りの方は教育総務課(市役所3階)または学校に一度ご家庭の経済状況をお聞かせください。

受付に必要な持ち物は特にありませんが、申請をその場でする場合は 4.(1)申請に必要な書類 が必要です。申請書は受付後にお渡しますが、課税証明書はご自身で発行を依頼し、提出していただく場合があります。

※ ① If you are experiencing financial difficulties, please first consult with the Education General Affairs Division (3rd floor of City Hall) or your child’s school to discuss your household’s financial situation.

You do not need to bring any specific documents for this initial consultation.

However, if you wish to submit your application on the spot, you will need the documents listed in 4. (1) Required Documents for Application.

The application form will be provided to you after your consultation, but you may be required to obtain and submit your own Taxation Certificate separately.

令和 8 年1月1日に湖西市外に住居登録があった方は、過去の住居登録地へ課税証明書の発行を依頼し提出が必要です。

If your residence was registered outside Kosai City as of January 1, 2026, you will need to request the issuance of a taxation certificate from the municipality where you were previously registered and submit it with your application.

※前年度就学援助の認定を受けた場合でも、援助を希望される方は毎年申請が必要です。

前年度申請し、認定された世帯については1月上旬にご自宅に継続申請書を郵送します。

※ Even if you were approved for school assistance in the previous year, you must apply every year if you wish to continue receiving assistance.

For households that applied and were approved in the previous year, a continuation application form will be mailed to your home in early January.

5. 就学援助費の支給時期・方法

5. Payment Schedule and Method for School Assistance

(1)支給時期：8月中旬・12月中旬・3月中旬の3回、学期毎に支給します。(時期は目安です。)

(1) Payment Schedule

Payments will be made three times per year—mid-August, mid-December, and mid-March—once each semester. (Dates are approximate.)

(2)支給方法：支給方法は以下の2つです。お子さんが通う学校と相談の上、選択してください。

- ① 教育委員会から保護者様の金融機関口座へ直接振り込む方法
- ② 教育委員会から学校長口座に振込を行い、学校徴収金の一部に充当する方法

(2) Payment Method

Please choose one of the following methods after consulting with your child's school:

1. Direct deposit from the Board of Education into the guardian's bank account.
2. Deposit into the school principal's account, to be applied toward part of the school fees collected by the school.
